The Mechanical Switchgear Designer is authorized to make decisions relating to the design and will have them approved by the Electrical Engineering Manager. The Mechanical Switchgear Designer possesses technical proficiency in the specification and design of electrical switchgear; prepares detailed design calculations and drawings with little supervision.

POSITION DUTIES / RESPONSIBILITIES:

- Prepare detailed design drawings including:
 - General arrangement drawings for electrical Distributions
 - Detail parts and assemblies using SolidWorks
 - Create traveler packages and shop drawings
 - Prepare detailed bill of materials for projects
 - Create programs for production machines
- Create / modify drawings using SolidWorks and AutoCAD
- Estimate materials used and complete material charge sheets
- Responsible for guiding shop personnel with assembly of completed designs
- Responsible for preparing calculations for bus and enclosure design (bracing and conductor sizing) to ensure compliance with CSA C22.2-31 switchgear requirements
- Ensure all project documents are organized and kept as required within REV's document management system

- Collaborate directly with project managers, clients, electrical utilities and regulatory agencies (Electrical Safety Authority, municipalities, etc.) to ensure that designs comply with all customer and regulatory requirements
- Occasional site visits will be required to acquire information for design and installation of new equipment and retrofits
- Other duties and tasks as assigned by management to ensure REV's goals and objectives are met
- Performs all duties so as to meet the responsibilities listed in REV's Safety and Human Resources Policy Manual
- Performs duties according to REV's quality system procedures and work instructions

- Drafting/Design experience in industrial project environments (minimum 2 years)
- Good knowledge of SolidWorks (minimum 1 year)
- Knowledge of AutoCAD is considered an asset
- Previous steel design experience (preferred)
